1. Introduction

Welcome to Bookmesocial.com,

Bookmesocial.com ("us", "we", or "our") operates https://bookmesocial.com/ (referred to as "Service") & other related companies/websites

This Privacy Policy governs your visit to https://bookmesocial.com/ & other related companies/websites, and explains how we collect, safeguard and disclose information that results from your use of our Service.

We use your data to provide and enhance the Service. By using the Service, you agree to the collection and use of informationin accordance with this policy. Unless otherwise defined in this Privacy Policy, the terms used in this Privacy Policy have the same meanings as in our Terms and Conditions. Our Terms and Conditions ("Terms") govern all use of our Service and together with the Privacy Policy constitutes your agreement with us ("agreement").

2. Definitions

THE USERis the individual using our Service. The User corresponds to the Data Subject, who is the subject of Personal Data.

API DATAis the data that we collect from social media API when you give us access to that particular information.

3. Information Collection and Use

We collect various types of information for different purposes to provide and enhance our Service to you. 4. Types of Data Collected

Automated Decision Making and Profiling.

23.Cookies

What are cookies?

We may collect information using "cookies." Cookies are small data files stored on the hard drive of your computer or mobile device by a website. We use two broad categories of cookies: (1) first party cookies, served directly by us to your computer or mobile device, which are used only by us to recognize your computer or mobile device when it revisits our website; and (2) third party cookies, which are served by service providers on our website, and can be used by such service providers to recognize your computer or mobile device when it visits other websites.

Cookies we use

It includes the number of visitors to our website, the websites that referred them to our website, the pages they visited on our website, what time of day they visited our website, whether they have visited our website before, and other similar information. We use this information to help operate our website more efficiently, to gather broad demographic information and to monitor the level of activity on our website. We use Google Analytics for this purpose. Google Analytics uses its own cookies. It is only used to improve how our website works. Social Media Cookies - These cookies are used when you share information using a social media s haring button or "like" button on our website or you link your account or engage with our content o n or through a social networking website such as Facebook, Twitter or Google+. The social network will record that you have done this.

Disabling cookies
